\_\_\_\_ 1. I currently hold a valid driver's license and carry up to date car insurance. I understand that I must have a current valid driver's license, up to date car insurance, and a parking decal by **August 05, 2022.**

NOTE: Min morning/day does not automatically guarantee you to a parking space.  
You must go through the proper procedures that all students must do.

I currently do not hold a valid driver's license nor do I have insurance but I am planning on obtaining such items either before school starts on August 1, 2022 or by the start of 2<sup>nd</sup> semester, January 3, 2023 (for whichever semester I plan on having min day). I plan on applying for a student parking permit for the 2022-2023 school year. Once I obtain the license and insurance, I will provide a copy of each to the counseling office before school starts or the semester that the selected Minimum Morning/Day starts.

# Minimum Morning/Day Rules

In order to qualify for Minimum Day, high school seniors must abide by these provisions:

1. Minimum day is a privilege for seniors and such privileges may be revoked at the discretion of the school administration.
  - a. If their privileges are revoked, it is possible that the student will not earn credit for a class that they enter depending on when they enter the class.
2. Participating students are subject to the same rules and regulations as full-time students, including disciplinary actions and extra-curricular eligibility.
3. Earned 17.5 credits prior to Fall Semester participation and 19.5 credits prior to Spring semester participation.
4. Students do NOT earn credit for Minimum Day.
5. Must have passed or be enrolled in the specified courses for HS graduation.
6. May be released for ONE class per day ONLY.
7. May not be scheduled for Min day in conjunction with Mentorship or WBL in the same day.
8. Eligibility for extra-curricular activities (including sports) may be affected if any classes are failed, dropped, or audited on the minimum day schedule. **(NOTE: students must pass a minimum of 3 classes/credits each semester to meet extra-curricular eligibility requirements).**
9. **Students who do not drive MUST get approval for minimum day from Mr. Autry!**
10. **Students are NOT allowed on campus during their scheduled Minimum day/morning period unless they have special permission from an administrator to remain on campus.**
  - a. Students will NOT have access to a morning bus if he/she has minimum morning OR an afternoon bus if he/she has minimum day for 4<sup>th</sup> period.
  - b. Students will not be permitted to remain inside of the building despite weather conditions.

Please email your counselor if you have any questions/concerns.

**STUDENTS ARE NOT ALLOWED ON CAMPUS DURING THEIR SCHEDULED MINIMUM DAY/MORNING PERIOD UNLESS SPECIAL PERMISSION IS ARRANGED THROUGH ADMINISTRATION. FAILURE TO LEAVE CAMPUS IMMEDIATELY WILL RESULT IN A SCHEDULE CHANGE AND MINIMUM DAY BEING REVOKED.**
